Ms. Laforgia questioned why Of Mice and Men was still in the curriculum. Ms. Laforgia questioned why if this curriculum was so great, why the strong arm to pass it. Ms. King quoted anti-semetic tweets by Trevor Noah. Ms. King stated that the district can find better authors than Trevor Noah.
